1. Fungi of Woowookarung

Exploring the fungi of Woowookarung

Well known Naturalist and Fungi Expert, Alison Pouliot presented a stunning display of fungi of Woowookarung at the Eureka Centre on Wednesday March 30th 2022.

Woowookarung is home to many varieties of Fungi and Alison encouraged locals to take time and look carefully at what is growing in the Forest.

Alison explained the role of fungi in tree and plant health and how fungi are every important in keeping soil and flora healthy.

In her view the worst thing a land owner can do is to rake vegetated areas of the leaves and litter which are where the fungi thrive. If the Fungi are thriving then the trees and plants will thrive also

"Alison was a bit like a fungi rockstar and had the full house audience intrigued!" attendee Cr Coates said in a comment on Facebook.

The adjacent Park bushland around Greenhill Rd, adjacent trails and tracks all got a good clean.



3. City of Ballarat advertises for Planners

The ad below appeared In a recent Age newspaper. The City of Ballarat is looking for a range of planners for the city.

Featured as the backdrop to the ad is our own Woowookarung Regional Park and the Canadian Corridor. Hopefully the City will recruit some environmentally sound planners and restart the stalled "Living Corridors Plan" Also waiting for the planners to get to work, is the Ballarat East Township Plan which began with community consultation in late 2015 and was in draft form in 2018 and has been gathering dust ever since.

Meanwhile the developers keep on rolling over the east.

4. Bird of the Month VII

Grey Butcherbird (Cracticus torquatus)

Not familiar with Grey Butcherbird? Visualise a bird that looks like a hybrid of Australian Magpie and Laughing Kookaburra. Firstly, Grey Butcherbird resembles Australian Magpie with its black, white and grey plumage, and bill colouration (apart from the hooked tip that magpies lack),

piping vocalisations and mimicry, and ancestry. Secondly, Grey Butcherbird resembles Laughing Kookaburra in their large, heavy bill, and predatory instincts (pouncing from a perch-start on lizards, small birds and insects). In fact, the physical similarities to kookaburras are such that the immature (i.e. adolescent) Grey Butcherbird is described as "... resembles a 'little kookaburra'" in Pizzey & Knight's 'Birds of Australia' field guide. Size-wise, Grey Butcherbirds, at 24-30cm, are roughly the length of a Rainbow Lorikeet.

Inhabiting eucalypt forests and woodlands; parks, gardens, golf courses; and treed watercourses, roadsides and

shelterbelts; Grey Butcherbirds occur in singles, pairs and family parties. Often heard before, or rather than, seen, the vocalisations are described as "loud, mellow", "vigorous" piping, with "varying phrases", and also "staccato and rollicking" shrieks in aggression.

Grey Butcherbirds are aggressive near the nest, with both sexes fiercely defending a clutch of 3-5 eggs, perhaps even diving on intruders. The female incubates the eggs, and mature offspring may remain in the parents' territory for up to a year post-maturity, to help rear the following year's brood. Uneaten food — which, in addition to aforementioned animal prey, also includes fruits and seeds — may be wedged in a forked branch or impaled on a pointy branch, a la butcher's hook; hence, the name 'butcherbird'.

Next time you wander through Woowookarung Regional Park, or another forest, park or garden in the Corridor, keep an ear out for the melodic piping of the kookaburra-like cousin of the magpie – and be sure to refrain from venturing too close to its nest!

5. Development proposal at Haymes Rd Mt Clear

A proposal to develop the property at 43 Haymes Rd was advertised in early March. The development proposed the destruction of 2.7 hectares of Koala habitat.

The property contains a significant amount of mapped Koala habitat which has been ignored in the proposal.

Local residents have banded together to object to the proposed destruction and to urge the council and developer to come up with a sensible plan. Further information at: keephaymesbeautiful@gmail.com and

The FoCC has lodged an objection based on the failure of the developer to apply the Ballarat Planning Schemes properly.

The property is zoned Neighbourhood Residential Zone (NRZ) and is available to be subdivided, however any subdivision must comply with the Ballarat Planning Schemes KOALA AND KOALA HABITAT PROTECTION 22.04 clauses. Bushfire overlay requirements also apply.

The property is well known for Koalas as shown on the map on page 5 headed 8. **Koala Sightings**.

The proposed development is on the west side of 55 Recreation Rd, the City of Ballarat's new Bushland Reserve and site of the FoCC Bunny Trail.

On Saturday March 19th local residents viewed the Bunny trail site and walked through to the Woowookarung Regional Park end.

7. <u>Draft Victorian Koala strategy consultation</u>

The Victorian Government has released the long-awaited draft Victorian Government Koala Management Strategy in late February.

The FOCC committee has made a response to the Strategy. The FoCC view is that the strategy has some very good intentions, particularly the proposal to undertake Genetic testing of Koala because of the concern many of Victoria's Koalas all originate from a very small gene pool. Things that the FoCC believes would make a difference to Ballarat's Koalas are:

- The provision of clear guidelines, and a process to apply those guidelines, to have vehicle speed limits reduced in Koala habitat areas.
- The provision of clear guidelines, and a process to apply those guidelines, to have dog free or dog restrictions applied as a "must do" - not as an optional matter in Koala habitat areas.
- By way of regulation, the involvement of DELWP in the protection of Koala habitat. DELWP should be complimenting the City of Ballarat Koala Plan of Management by recognising the importance of the City of Ballarat Koala Habitat Overlay ESO5. DELWP should be keen to support any other municipal area that may in the future have such an overlay or similar overlay.
- Ensuring that current regulations protecting Koala habitat, such as the City of Ballarat's ES05 overlay, are complied with by making sure the planning regulations are in the "must comply" category not the weaker "should comply".
- Develop new <u>state wide</u> Koala habitat protection rules that include DELWP and Catchment Management authorities, as well as Road authorities.


On the website you can download the draft strategy and provide feedback via the survey tool. The public consultation period will run from 21 February 2022 until 3 April 2022.

8. Koala sighting


Recent Koala sightings images are below:

12. The Mount Clear Bike Path Circa 1975-6

The origins of the Mount Clear Bike Path was a talking point with a former local resident at the Buninyong Smart Living and Building Expo

The map to the side shows the very new exposed trail in its infancy (Green arrows).

The trail was built to provide safe access for students at the new Mt Clear Technical High School campus which opened in 1976. Geelong Road was deemed too dangerous for students to cycle along and the bike path was the solution. The path began at Elsworth St and terminates on Recreation Rd. Today the path follows the original alignment except for the Canadian Lakes section. The map clearly shows a very open path running beside a bare or gorse infested creek. The massed tree planting that

is now evident came later and today the trail is a testament to the hard work and vision of all wonderful people who worked so hard in the late 70's and 80's and beyond.

For Ballarat this trail really was a first. The first bike path had just been built along the Yarra River in Melbourne and the Cycling was just starting to become fashionable again. It is possible that this trail was the first regional bike path in Victoria. Discuss!

13. Trees Gone

One of the problems of keeping old trees in the Corridor is the constant removal of old trees because of the perception that they may fall.

This tree in Spencer St Canadian fell out with a nearby resident and the rest is history.

The FoCC understands that when faced with a claim that a tree is dangerous, the Council officers are often faced with a no-win situation.



Spencer St tree lopped already. It was gone a week later.

The FoCC lodged two letters of complaint the first in

February, no official answers yet.

The FoCC is also aware of properties that are purchased with the knowledge of significant trees adjacent. But once new owners arrive, they start to agitate to remove the trees.

When the Living Corridors Strategy Plan is restated by the City, the FoCC will be strongly arguing for better tree protection for street trees particularly when people purchase a property with a big tree on the roadside.

An example of good planning decisions

14. The Canadian Forest story, another chapter

The story of the Canadian Forest from the Goldfields era through to the present, is often a story of vested interests wanting to use the land for gain or to solve a problem cheaply.

A timeline of major interventions is:

1860: By 1860 the forest had literally been cut out to supply timber for bracing mine shafts and for firewood. In 1865 the forest was promoted as a "State Forest" http://www.parliament.vic.gov.au/papers/govpub/VPARL1864-65No77.pdf

During the next century the forest was repeatably harvested for wood and many gullies sluiced in the quest for gold. Two rifle ranges, Cremorne and Commonwealth were established in the northern end of the forest. By the end of the second world war, the forest was again depleted due to wartime cutting. Sections were just stumps. In the 1950's domestic firewood lots were available to locals and the forest was regularly "thinned"

<u>1960:</u> Fast forward to the 1960's and the pro development Premier Henry Bolte, agreed to annexe 240 hectares of the forest in order to plant a large pine plantation to supply Laminex Industries.

1974: 340 Hectares of the northern end of the Forest was proposed to be annexed as a site of a food processing plant. Fast action by the Field Naturalists Club Ballarat and others saw off this land grab. See Spikey News, September 2021, issue 81

1980: The Land Conservation Council in its landmark findings saw the forest as primarily a timber production resource and secondly as a recreation area. https://veac.vic.gov.au/investigations-assessments/previous-investigations/investigation/ballaratarea-lcc-1982


<u>1994</u> The Mt Clear Outline Development Plan was produced for the Shire of Buninyong just prior to Council amalgamation.

The ODP never made it into practice. Parts of the ODP formed the later 2005 Canadian ODP which became the basis for the Koala Plan of Management.

The map below says it all.

Note the black dotted **planned road** running from Kline St in the North through to Olympic Avenue in the south. And all the infill streets and court bowls in what is now the western side of Woowookarung Regional Park. The **Red line** is the Woowookarung Regional Park Boundary.

2012 In 2012 the plantation lease owners, East Gippsland Plantations, handed back the failing Blue Gum Plantation to the Napthine Government.

See the image at the end of this issue on page 8. Minister Gordon Rich Phillips wrote that the Department of Environment and Primary production was working to determine "if the land may be released for disposal" The FoCC understanding was that was code for a sell off! And FoCC was established and the winning of the case for a park is now history.
